This agreement to indemnify and hold harmless Indemnitees includes my responsibility to pay all attorney fees, court costs and other reasonably related legal costs incurred by Indemnitees and arising from or relating in any respect to my child's/ward's participation in the City of Madison Regatta/4th of July Parade.
