We spoke briefly about an application that Tirrie Jenkins/Madison Christian Health has for their property at 524 Jefferson St. They are seeking a Conditional Use Permit for a Rooming & Boarding House at 524 Jefferson St which they state in their application would be "synonymous with each adjoining house".
