## OVERVIEW

Legacy of Hope Madison (LHM) was developed to offer a safe rooming and boarding house to adults and families who are experiencing difficulty obtaining transient housing, and would otherwise be homeless. Jefferson County Indiana lacks a room and boarding house to meet the immediate housing needs of individuals facing sudden displacement. The LHM was devised to promote affordable housing to low income and individuals who are agreeable to shared housing. It will provide year-round immediate safe sheltering for individuals needing low-barrier housing, immediate referrals to information and services. LHM's is located in an ideal location that allows participants access to most of Jefferson County health and human services.
