Hi Joe and Nicole,

Last night Ms. Jenkins and her brother testified more than once that they are not responsible for the state of the properties 524 Jefferson or 525 Gerry Lane because they were not in control of them until July/August 2023. The blame for the neglect and the tenants and the criminal complaints was laid squarely upon their parents, especially the mother.

At the start of my testimony, I asked that the Board consider the facts of this situation. We need to have an honest reckoning of these properties and who is responsible for their current state before we can even begin to speculate about the future, with or without the application before the board. Our point is that the record of neglect falls on the ownership LLC and specifically Ms. Jenkins.

You may already possess these documents, but I ask that they be distributed to the Board and entered on the record.

- 1. The State of Indiana approved the creation of this LLC on 10/28/2020. The name of the Registered Agent is Tirrie Jenkins of 2226 Logans Point Dr., Hanover, IN. The Articles of Incorporation are attached.
- 2. On 1/31/2022, ownership of 524 Jefferson Street is recorded as MCHDS. The county ownership record is attached.
- 3. On 2/8/2023, the State recorded a "Business Entity Report" document for MCHDS showing Tirrie Jenkins (same address) as the Chair of the LLC. This is also attached.

The ownership facts are simple and the Board should understand them. The applicant's LLC has legally owned 524 Jefferson for the last 24 months and the applicant, Tirrie Jenkins, has been the Chair of the LLC since it was created in 2020 to the present.



Exhibit A to the Articles of Incorporation of Madison Christian Health and Developmental Services, Inc.

Article II - Statement of Purpose

Madison Christian Health and Developmental Services, Inc. (the "Corporation") is organized exclusively for religious, charitable, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1985, as amended, (the "Code") or the corresponding provision of any future United States Internal Revenue Service statute, including, but not limited to, providing health and human services to promote the social welfare and emotional stability of individuals residing in Jefferson County, Indiana and surrounding communities.

Notwithstanding the foregoing or any other provision of these Articles of Incorporation:

- (a) No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable and fair market compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above.
- (b) The Corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office; and, except as may be permitted pursuant to Section 501(h) of the Code, no substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempting, to influence legislation.
- (c) The Corporation shall not carry on any other activities not permitted to be carried on:
 - i. by a corporation exempt from federal income tax under Section 501(c)(3) of the Code; or
 - ii. by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code.
