ORDINANCE 2022-21 (Krebs)

AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF MADISON, INDIANA AMENDING THE LOCAL PLAN FOR EXPENDITURES OF ARP FUNDS

Mayor Courtney gave an overview. The City of Madison received an appropriation of ARP funds of ~\$2.7 million to allocate to different areas. There are 6 categories: stormwater infrastructure, matching grant funds, speeding recovery of tourism, premium pay for essential workers, public revenue loss due to COVID, and City of Madison parks improvements. To date, \$681,000 have been used leaving the balance to appropriate: 50% to parks improvements, 22% to stormwater infrastructure, 4% to matching grant funds for public safety, 4% to speeding the recovery of tourism, 11% to premium pay for essential workers, and 10% for public sector revenue loss due to COVID. No questions or comments, moving on to the third reading.

ORDINANCE 2022-22 (Krebs)

AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF MADISON, INDIANA AMENDING SECTIONS 96.99, 98.06, SECTION 153, 155, AND 11.60 OF THE PLANNING, PRESERVATION, AND DESIGN SCHEDULE OF FEES

Thevenow made a comment of objection saying the increases are too high, especially the introduction of an application fee. Thevenow moved to change the proposed fee for HDBR application fee from \$25 to \$0. No second made, the motion dies. Nicole Schell explained the current application has a fee of \$15 with a \$2 per sign charge that helps cover legal costs. L. Dattilo disagreed with Thevenow stating that \$17 won't stop anyone from participating in the historic guideline process. Moving on to third reading.

PUBLIC COMMENT: Jan Vethrus- agrees with her rep. Thevenow. She explained it is necessary to encourage people to do the right thing and that increasing the fees is offensive as a taxpayer and is not helpful to charge people to get them to do something they are not comfortable with. It was explained that there has been no shortage of applications, and people are accustomed to paying fees. Mayor Courtney explained that if the City wants to continue providing its service level, the minimal fees will not slow down growth or applications. Camille Fife- Agreed with Jan V. Explained she feels the application fee and reading fee are a bit too high and to consider that for future decisions.
