Common Council Minutes

MEETING DATE: Tuesday, May 6, 2025, at 5:30 PM **MEETING PLACE:** City Hall, 101 W. Main Street, Madison, IN 47250

The Common Council of the City of Madison, Indiana, met in regular session at 5:30 P.M. at City Hall, 101 W. Main Street, Madison, IN 47250.

Mayor Bob Courtney opened the meeting with the Lord's Prayer, followed by the Pledge of Allegiance to the Flag.

Present: Thevenow, Krebs, Dattilo, Schafer, Storm, Wilber, and Bartlett were present (7-0).

Minutes: Bartlett moved to approve the April 22, 2025, regular meeting minutes, seconded by Krebs. All in favor, motion carried (7-0).

Presentation of petitions, memorials, remonstrances, introduction of motion & guests: None.

Resolutions or bills: Resolution 2025-7C: Transferring Certain Appropriations and Revenue between Funds: *Transfers amounts between positive/negative funds for YE2024 clean-up.* **Motion:** Krebs moved to approve Resolution 2025-7C, seconded by Bartlett. **Roll Call Vote:** Thevenow – Y, Krebs – Y, Dattilo – Y, Schafer – Y, Storm – Y, Bartlett – Y, Wilber – Y. All in favor, resolution passes (7-0).

Resolution 2025-8C: Approving the Issuance of TIF Revenue Bonds: *Approves issuance of TIF bonds in the amount* <=\$4.9 *million as authorized by the Madison Redevelopment Commission, the purpose of which is to meet the city's 2025 parks and housing investment plans.* **Motion:** Storm moved to approve Resolution 2025-8C, seconded by Schafer. **Roll Call Vote:** Thevenow – N, Krebs – Y, Dattilo – Y, Schafer – Y, Bartlett – Y, Storm – Y, Wilber – Y. Majority rules, resolution passes (6-1).

Emily McKinney, Associate Director of Economic Development, gave a brief presentation on the four proposed projects. Gary Smith, a representative from Reedy Financial Services and the city's financial advisor, followed with an overview of the bonding analysis for the 2025 RDC Capital Bond. Kevin Kellums, Jefferson County's representative on the Southern Indiana Redevelopment Authority, also spoke, sharing insight into the RDA's role, responsibilities, and goals as a redevelopment authority. All presentations are available to view on the City of Madison YouTube channel.

Councilmember Thevenow shared his thoughts on the process and the steps he believes should be taken regarding Resolution 2025-8C. Councilmember Krebs provided the public with a clear, easy-to-understand explanation of the approval process for the four proposed projects. Councilmember Storm outlined the data and key factors he takes into consideration when reviewing and voting on resolutions like the one currently proposed, helping the public better understand his decision-making process.

The meeting featured a public comment period during which several community members shared their perspectives on the proposed developments, with a focus on the potential zoning changes within the Riverfront District. Key themes included concerns about the visual impact of new construction on Madison's historic character, the need to establish appropriate zoning regulations prior to allocating financial resources to redevelopment, and

skepticism regarding whether the proposed plans would effectively address the city's housing shortage. A list of speakers is available for public viewing at City Hall.

Ordinance 2025-6: Reestablishing Cumulative Capital Development Rate: *Updates the city's 1985 ordinance regarding the CCDF rate as permitted by state statute.* Mayor Courtney provided an overview of this ordinance and uses of CCDF funds. Charles Ricketts, of 707 W. First Street, asked for an estimate of how much the proposal would potentially impact property taxes.

Ordinance 2025-7: Rezoning 3483 North Michigan Rd: *Decision on favorable recommendation from Plan Commission.* Motion: Krebs moved to suspend the rules and move to second reading, seconded by Schafer. Roll Call Vote: Thevenow – Y, Krebs – Y, Dattilo – Y, Schafer – Y, Bartlett – Y, Storm – Y, Wilber – Y. All in favor, motion passes (7-0). Mayor Courtney asked Councilmember Thevenow if this was considered spot zoning. Thevenow responded that it was, but similarly zoned property was nearby, and that this was acceptable spot zoning.

Ordinance 2025-8: Rezoning 1145 W Second St: *Decision on favorable recommendation from Plan Commission.* **Motion:** Wilber moved to suspend the rules and move to second reading, seconded by Bartlett. **Roll Call Vote:** Thevenow – Y, Krebs – Y, Dattilo – Y, Schafer – Y, Bartlett – Y, Storm – Y, Wilber – Y. All in favor, motion passes (7-0).

Reports, recommendations, and other business from standing/select committees of City Council: Mayor Courtney - Appointment of Finance Standing Committee of Common Council: In light of this year's legislative session and several pending bills awaiting the Governor's signature—including measures on tax reform, the state budget, property taxes, road funding, franchise fees, and annexation—Mayor Courtney has announced the formation of a Finance Standing Committee. This committee will work collaboratively with the Director of Finance, the Mayor's Office, and the Clerk-Treasurer's Office throughout the upcoming budget planning cycle, with the goal of presenting a proposed budget to the community later this summer. Mayor Courtney has appointed Councilmembers Schafer, Bartlett, and Storm to serve on this committee.

Report of city officials: Director of Finance – Mindy McGee: Bid Awards for Community Crossings and Transfer Station: Last week, the City held bid openings for two separate projects. The first was for the 2025 CCMG infrastructure project focused on improvements to Main Street. Three companies submitted bids, and the contract was awarded to Allstar Paving with a bid of \$1.228 million. The second project bid opening was for the upgrades to the Transfer Station. Two companies submitted bids, and the contract was awarded to Sedam Contracting with a bid of \$627,000.00.

All in favor, motion passes (7-0).

Miscellaneous: None.

Public comment (per sign-up sheet): During public comments, Randy Bellamy inquired about who is responsible for inspecting sidewalk paving following excavations. Mark Viterna, of 716 W. Third Street, urged the Council to exercise caution in making economic decisions that may exceed the City's capacity to maintain. Deanna Shelley shared her opinions on the proposed projects outlined in Resolution 2025-8C. Charles Ricketts requested that the Plan Commission delay the rezoning consideration related to Resolution 2025-8C until the June meeting.

Mayor's comments: A moment of silence was observed in memory of Chris Taylor, a former employee of Sunrise Golf Course, who passed away last week.

NATIONAL HISTORIC PRESERVATION MONTH PROCLAMATION

Whereas, on June 8, 1906, President Theodore Roosevelt signed into law the Antiquities Act giving the US President the authority to create national monuments from public lands to protect significant natural, cultural, or scientific features; and

Whereas, on October 15, 1966, the National Historic Preservation Act, the most far-reaching preservation legislation ever enacted in the United States, was signed into law by President Lyndon B. Johnson. This legislation established the National Register of Historic Places and State historic preservation offices; and

Whereas, the National Register of Historic Preservation established May as National Historic Preservation Month in 1973 to promote historic places for the purpose of instilling national and community pride, promoting heritage and tourism, and showing the social, economic, and cultural benefits of historic preservation; and

Whereas, "Harnessing The Power of Place" is the theme for National Historic Preservation Month 2025, of which many examples can be seen throughout our National Landmark historic district as homeowners work with the history of their homes, rather than against, to breathe new life into old buildings; and

Whereas, the historic houses, buildings, and cultural sites in Madison help make it unique and foster local pride, maintaining community character while enhancing livability; and

Whereas, historic preservation is relevant for communities across the nation, both urban and rural, and for Madisonians of all ages, all walks of life, and all ethnic backgrounds; and

Whereas, it is important to celebrate the role of history in our lives and the contributions made by the City of Madison, Historic Preservation organizations, and dedicated individuals in helping to preserve the tangible aspects of heritage that have shaped us as a community; and

Whereas, Madison has beautiful architecture and many notable nationally designated buildings, a National Landmark historic district, and two National Historic Landmark sites; and

Now, Therefore, I, Bob G. Courtney, Mayor of the City of Madison, which was founded in 1809, do hereby proclaim: May 2025 as National Historic Preservation Month and, call upon the residents of the City of Madison to join others across the United States in recognizing and participating in this special observance.

ORDINANCE 2025-9

AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF MADISON, INDIANA AMENDING CHAPTER 73, SCHEDULE III, STOP INTERSECTIONS: ESTABLISHING TWO THREE-WAY STOP SIGNS FOR TRAFFIC AT THE INTERSECTIONS OF VAUGHN AND JEFFERSON AND VAUGHN AND BROADWAY

WHEREAS, a traffic investigation has been completed by the Madison City Police Department indicating it is necessary for a safe pedestrian crossing, traffic control, and that a stop be established for traffic travelling east and west on Vaughn Drive at its intersection with Jefferson Street, and at its intersection with Broadway Street, making both intersections three (3) way stops; and

WHEREAS, it would be in the best interest of traffic safety and control for said intersections to be changed as set forth above.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF MADISON, INDIANA that:

Section 1. Two three (3) way stops are hereby established for both east bound and west bound traffic on Vaughn Drive at its intersection with Jefferson Street and at its intersection with Broadway Street, establishing both intersections as three (3) way stops.

Section 2. The Common Council is hereby authorized to erect such signs and other traffic control devices as may be necessary to implement the intent of this Ordinance.

Section 3. Anyone failing to stop in accordance with these signs herein provided shall be guilty of a Class D infraction which carries a penalty outlined by the Violations Bureau.

Section 4. This Ordinance shall become immediately effective upon its adoption by the Common Council, signature of the Mayor, publication of notice as required by law, and posting of the stop signs at said intersections.

<u>Section 5</u>. Any Ordinance in conflict with this is hereby repealed.

ORDINANCE 2025-10

AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF MADISON, INDIANA ESTABLISHING THE JEFFERSON COUNTY BOARD OF TOURISM CONTROL FUND

WHEREAS, The Jefferson County Board of Tourism, the governing authority established to promote and develop Jefferson County's tourism; and

WHEREAS, The Jefferson County Board of Tourism will be making restricted and unrestricted grants or donations for various tourism related initiatives within the City of Madison; and

WHEREAS, the City of Madison wishes to establish a fund to deposit monies received from the Jefferson County Board of Tourism to the City of Madison initiatives,

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Madison, Indiana as follows:

- (A) A control fund is established to deposit monies received from the Jefferson County Board of Tourism. The monies will come as deposits for a specified purpose through an agreement for each deposit which will specify the accepted use of funds.
- (B) The fund shall be named the Jefferson County Board of Tourism Control Fund. All funds contained in the account shall be expended only for the exclusive purpose detailed in each restricted deposited agreement. The governing body of the City of Madison will review and agree to each deposited agreement prior to accepting funds and no further appropriation is required except for unrestricted donations.
- (C) The express and written approval of the Board of Public Works and Safety shall be obtained prior to the expenditure of funds from the account.
- (D) For each type of restricted deposit, separate and individual accounts shall be monitored to reflect receipts, disbursements, and current balances.
- (E) The fund shall be non-reverting and exist perpetually unless terminated by a subsequent ordinance enacted by the Common Council.
- (F) If the fund is terminated by a subsequent ordinance enacted by the Common Council, the remaining balance of the terminated account shall revert to the general budget of the Common Council.

ORDINANCE 2025-6

AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF MADISON, INDIANA REESTABLISHING THE CUMULATIVE CAPITAL DEVELOPMENT FUND

WHEREAS, the City of Madison has previously established a Cumulative Capital Development Fund (CCDF) and a corresponding rate pursuant to Indiana Code 36-9-15.5; and

WHEREAS, the CCDF Rate has trended below the maximum allowable by state law and is currently \$0.0334 per \$100 assessed value, a rate that was set in 1985 by ordinance; and

WHEREAS, the City of Madison Common Council find is necessary to reestablish the CCDF and raise the corresponding rate to \$0.05 per \$100 assessed value, the maximum rate allowed by Indiana Code 36-9-15.5.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF MADISON, INDIANA, that:

Section 1. A need now exists for the reestablishment of a Cumulative Capital Development Fund for the purposes set forth in Indiana Code 36-9-15.5.

Section 2. An ad valorem property tax levy will be increased and the revenues from the levy will be retained in the City of Madison Cumulative Capital Development Fund.

SECTION 3. The maximum rate of levy under SECTION 2 will not exceed \$0.0500 per \$100 of Net Assessed Valuation beginning with taxes payable in 2026 and thereafter, continuing until reduced or rescinded.

SECTION 4. The funds accumulated in the City of Madison Cumulative Capital Development Fund will be used for all uses as set out in IC 36-9-15.5.

SECTION 5. Notwithstanding Section 4, funds accumulated in the City of Madison Cumulative Capital Development Fund may be spent for purposes other than the purposes stated in Section 4, if the purpose is to protect the public health, welfare, or safety in an emergency situation which demands immediate action. Money may be spent under the authority of this section only after the mayor issues a declaration that the public health, welfare or safety is in immediate danger that requires the expenditure of money in the fund.

BE IT FURTHER ORDERED AND ORDAINED that a certified copy of this ordinance shall be submitted to the Department of Local Government Finance of the State of Indiana as provided by law. The tax rate for this Fund is subject to certification by the Department of Local Government Finance.

Cumulative Capital Development (CCD) Fund FAQs

Q: What is the CCD Fund and how is it used?

A: A CCD fund is a type of financial fund established by municipalities in Indiana in accordance with Indiana Code 36-9-15.5. The funds are accumulated through property tax revenue and can be used for any municipal purpose. The City of Madison appropriates CCD Funds through the budget process for expenditures related to repairs and maintenance, our Main Street reserve, infrastructure projects, and City beautification. The additionally funding will be dedicated to deferred maintenance on public buildings owned by the City.

Q: Is this a new tax imposed by the City?

A: No, this is not a new tax. The CCD Fund was adopted by ordinance on August 24, 1985, and has been part of the overall tax rate since its inception.

Q: What is the tax rate of the CCD?

A: Under Indiana law for municipalities in a county with a local income tax and who have had a CCD for three consecutive years or more, the maximum rate cannot exceed five cents (\$.05) per \$100 of assessed valuation.

Q: Why is the City reestablishing (increasing) the CCD tax rate?

While public officials in other communities have regularly addressed their CCD tax rates over the years, the City of Madison has not moved incrementally forward. Additionally, municipalities across the state, including the City of Madison, are faced with budget cuts due to recent legislation. As a result, we must find ways to increase our revenue streams so they we can continue to provide essential services to our community.

Q: How much additional revenue will this generate for the City?

A: At the current rate the City generates approximately \$246,000. The proposed increase will generate roughly \$98,000 of revenue.

Q: For what year is the reestablishment effective?

A: The reestablishment advertised and presented at the May council meeting is related to the year ending December 31, 2026. The State of Indiana requires the CCD fund for the next budget year to be established by May 31 of the prior year (so for the 2026 budget year the CCD must be reestablished by May 31, 2025). Due to this requirement by the State, the CCD cannot be reestablished during the budgeting process in late summer/early fall.

Q: What is the cost of the CCD tax for a property owner?

A: This is difficult to answer because the amount each property owner pays depends on their appraised home value, district, and whether they are over the property tax cap. In addition, the property tax bill received includes every taxing authority within the jurisdiction to arrive at the overall tax rate.
