Common Council Minutes

MEETING DATE: Tuesday, September 23, 2025, at 5:30 PM

MEETING PLACE: City Hall, 101 W. Main Street, Madison, IN 47250

The Common Council of the City of Madison, Indiana, met in regular session at 5:30 P.M. at City Hall, 101 W. Main Street, Madison, IN 47250.

Mayor Bob Courtney opened the meeting with the Lord's Prayer, followed by the Pledge of Allegiance to the Flag.

Present: Thevenow, Krebs, Dattilo, Schafer, Storm (via internet), Bartlett and Wilber, were present, (7-0).

Minutes: Dattilo moved to approve the September 2, 2025, regular meeting minutes, seconded by Krebs. All in favor, motion carried (7-0).

Presentation of petitions, memorials, remonstrances, introduction of motion & guests: Welcome students from Madison High School.

Resolutions or Bills:

Ordinance 2025-16: Amendment to Zoning Map and Schedule of District Regulations; Sponsor J. Wilber and L. Dattilo:

An Ordinance of the Common Council of the City of Madison, Indiana Amending Certain Sections of the Zoning Ordinance and the Zoning Map and Schedule of District Regulations of the City of Madison.

Mayor Courtney described the history of the various programs that have been developing since 2021 regarding READI One investments and READI 2.0 in 2023, our Comprehensive Plan from our predecessors and our Destination Madison Plan enacted in 2021. We have been having the public discussion regarding Riverfront zoning since May of 2025. We are here tonight to go over the adoption of the Ordinance and the Plan Commission recommendation. Mayor Courtney expressed his willingness to answer questions of the Council and reminded everyone this is their opportunity to discuss their concerns with the council.

Attorney Joe Jenner read the opening of the Ordinance as; "This is the first reading, first of two readings of the Ordinance 2025-16, Amendment to Zoning Map and Schedule of District Regulations, sponsored by Councilman Wilber and Councilperson Dattilo".

Council member Thevenow and Council member Schafer presented amendments to the council and read over the summaries of each amendment for the public.

For further reference, a copy of the sign-in sheet and a list of speakers can be found in the Clerk-Treasurer's office as a part of the minutes.

Mayor asked Council if they have any remarks they would like to make ahead of the public discussion and asked Councilwoman Krebs to lead us into the rules for tonight's public discussion.

Councilwoman Krebs asked her fellow council members if they have any comments before they get started listening to the public comment. Councilmember Schafer said he would wait for public comment first. Councilwoman Krebs

said that two of our councilmen gave Amendments and different setbacks for the Ordinance and obviously they have not had time to digest the paperwork. Councilwoman Krebs said they are going to form a committee to digest the setback and boundary amendments. She stated that the Council has been busy responding and listening to various people in the community, so when you come up please don't accuse the council of not listening. Some of the concerns have been addressed already, including the concern the Ordinance allowed buildings to be too tall, so they took off an entire level in the Ordinance and reduced the boundaries by 2/3rds and then there were some incorrect uses and sources that needed to be adjusted. Tonight, they are looking at adjusting the setbacks. Councilwomen Krebs reminded the public that the council is happy to listen, however, tonight is not a question and answer, only public comment. She reminded the public that there are quite a few signed up to speak and that there is a 4-minute time limit, anyone that is rude will be asked to leave.

After much public comment, see below, Council members Thevenow and Schafer gave a verbal summary of their Amendments for the council's review.

Councilman Thevenow asked that a select committee be appointed this evening pursuant to our Ordinances, specifically to look at these amendments and what we are talking about tonight prior to our next meeting and report back to council on what they have discussed, those meetings would be open to the public.

Mayor Courtney remarks:

Regarding meetings that have happened every month since May, the Riverfront District proposal came out a complete review of our entire Zoning Ordinance and subdivision standards that have been going on for about 10 months with meetings of the Steering Committee that included members of the BZA, Plan Commission and members of the Mayor's Staff. You can look across the city and see the impact of good investments. I appreciate the amendments presented tonight because we want to get this right. I believe this is the 3rd or 4th amendment since the original proposal since introduced back in May, because of listening to the public input and talking with those people over the course of 5 months to try to get it right. I appreciates the amendments because it acknowledges the fact that we need a plan, we don't currently have a plan for that area of our riverfront and it is suffering like other parts of our community, it is suffering from disinvestment.

We believe that we can prudently bring investment to the riverfront, as it was stated earlier, both can coexist, enjoyment of our riverfront as well as prudent development on our riverfront. We have followed processes as defined by law, it's been an open process and I am looking forward to digging into the amendments. I agree with Councilman Thevenow, I will appoint a select committee of councilmember to review the proposed amendments, I will make the amendments available publicly tomorrow and we will continue with this process as we head into the October 7, 2025, meeting. It is about location. Downtown Madison is a very desirable location, contrary to what was said tonight, you can't do this just anywhere. Anywhere we go and any development we've done, there has always been conflict because no one wants the environment around them disturbed. I understand and we have to take those changes very seriously, but location is extremely important and downtown Madison needs a boost for its economy as well as the businesses here. We want them to thrive 365 days a year, not just when tourists are in town. Location is important and that is a location we feel is important to downtown and to the local economy. I appreciate the comments, and we will continue to have good dialogue and collaboration. I can say this with all my heart, this council and I have been listening to all remarks. We may agree and we may agree to disagree, but this council is really working hard to get it right along with myself and my staff. A good outcome is dependent upon a good plan, and I believe we are closing in on a good plan and it is a better plan because of remarks here and over the course of the last 5 months.

Councilman Schaefer stated that anyone that was a part of his poll/survey or that read his poll results needs to know that the poll was not a scientific poll and should not be portrayed in that manner, it was for informational use only.

Councilman Bartlett asked if we need a Motion to refer the amendments to a special committee, Attorney Joe Jenner said no, that what we have are 2 council members that would like to see a special committee to look at those issues on their amendments.

Council member Thevenow and Council member Schafer presented amendments to the council and read over the summaries of each amendment for the public.

WHEREAS, Code Enforcement Officers provide safety and welfare to citizens in the nation through enforcement of local codes and ordinances on issues of zoning, environmental, health, life safety, and blight elimination; and

Exhibit A

Section 4.50 - Riverfront District (RF)

This district is intended to create a vibrant mixed-use district that capitalize on the city's location along the Ohio River to serve residents with shopping, dining, entertainment, and living options while also supporting tourism and local events within Madison. Specific provisions for this district are set forth in Section 6.31.

Section 6.00 - Specific Application of District Regulations

The restrictions set out in Sections 6.10-6.31, inclusive, apply to uses in the individual districts.

Section 6.31 - Riverfront District (RF)


- A. General restrictions
 - 1. Floor Area Ratio No restriction
 - 2. Lot Area No restriction
 - 3. Lot Width No restriction
 - 4. Side Yard and Rear Yard Setback 0 feet with recorded 5-ft maintenance easement for adjoining parcel, measured from the property line inward or minimum of 3-ft
 - 5. Front Yard Setback 0-ft
 - 6. Height Restriction 35-ft, measured from the average of the highest and lowest Flood Protection Grade (FPG) on the parcel
 - 7. Signage within the Historic district All signs within the Historical District require a Certificate of Appropriateness and must comply with the signage requirements of the City's Historic Ordinance 151.36.
 - B. Restrictions for Permitted Use
 - 1. All permitted uses listed in Section 7.00 Official Schedule of District Regulations shall conform to the General Restrictions.
 - i. Signs intended to been seen outside of the lot line:
 - Shall not be obstructed in any way a driver's vision of the road or hinder his passage in any way. Further, no sign shall be placed so as to hinder or obstruct any pedestrian path. Preferably, the signs should be flush with the building façade.
 - 2. Signs shall meet the requirements of the Historic District and always be properly maintained.
 - ii. Fences, Walls and Hedges:
 - Notwithstanding other provision of this ordinance, fences, wall and hedges may be permitted in a yard or along the edge of any yard, providing that driveway entrances are not shielded by fences, wall and hedges in such a way as to obstruct the view of a driver entering a public road from the driveway. All fences and walls must meet the requirements of the Historic District.
 - iii. Parking areas. All areas used for parking shall be located in the rear or side yard unless located in a parking structure that is integrated into the primary

- structure. All parking areas shall be screened from the view of the surrounding dwelling units.
- iv. Lighting. Lighted areas shall be approved prior to development and shall be placed in such a way that they do not infringe upon the rights of adjacent property owners.
- C. Restrictions for Conditional Uses
 - 1. All conditional uses permitted in the Official Schedule of Uses shall conform to the General Restrictions. In addition, the following restrictions, as appropriate, shall be observed.
 - i. Signs intended to been seen outside of the lot line:
 - Shall not be obstructed in any way a driver's vision of the road or hinder his passage in any way. Further, no sign shall be placed so as to hinder or obstruct any pedestrian path. Preferably, the signs should be flush with the building façade.
 - 2. Signs shall meet the requirements of the Historic District and always be properly maintained.
 - ii. Fences, Walls and Hedges:
 - Notwithstanding other provision of this ordinance, fences, wall and hedges may be permitted in a yard or along the edge of any yard, providing that driveway entrances are not shielded by fences, wall and hedges in such a way as to obstruct the view of a driver entering a public road from the driveway. All fences and walls must meet the requirements of the Historic District.
 - iii. Parking areas. All areas used for parking shall be located in the rear or side yard unless located in a parking structure that is integrated into the primary structure. All parking areas shall be screened from the view of the surrounding dwelling units.
 - iv. Lighting. Lighted areas shall be approved prior to development and shall be placed in such a way that they do not infringe upon the rights of adjacent property owners.

WHEREAS, the Common Council of the City of Madison, Indiana concurs with the recommendation submitted to it by the Plan Commission.

A RESOLUTION OF THE PLAN COMMISSION OF THE CITY OF MADISON, INDIANA RECOMMENDING AMENDING THE CITY OF MADISON ZONING ORDINANCE, OFFICIAL ZONING MAP, AND SCHEDULE OF DISTRICT REGULATIONS

WHEREAS, The City of Madison Plan Commission is the body charged with the duty of reviewing all proposed amendments to the City of Madison Zoning Ordinance; and

WHEREAS, The City of Madison has a need for additional housing within the city limits; and

WHEREAS, The City of Madison has determined that some parts of the city zoned Open Space (OS) are buildable and should be allowed to be developed with a focus on housing; and

WHEREAS, it has been recommended that The City of Madison amend its Official Zoning Ordinance, Official Zoning Map, and Schedule of District Regulations be amended to establish a new zoning district known as Riverfront District (RF) for the purpose and intent to allow for development within downtown's Open Space (OS).

NOW, THEREFORE, BE IT RESOLVED BY THE PLAN COMMISSION OF THE CITY OF MADISON, INDIANA that the City of Madison Official Zoning Ordinance, Official Zoning Map, and Schedule of District Regulations to be amended as requested in the proposal attached hereto as Exhibit A, Exhibit B, and Exhibit C to establish a new zoning district known as Riverfront District (RF) is approved and hereby recommended for passage by the Common Council of the City of Madison, Indiana.

Section 4.50 – Riverfront District (RF)

This district is intended to create a vibrant mixed-use district that capitalize on the city's location along the Ohio River to serve residents with shopping, dining, entertainment, and living options while also supporting tourism and local events within Madison. Specific provisions for this district are set forth in Section 6.31.

Section 6.00 – Specific Application of District Regulations

The restrictions set out in Sections 6.10-6.31, inclusive, apply to uses in the individual districts.

Section 6.31 – Riverfront District (RF)

A. General restrictions

- 1. Floor Area Ratio No restriction
- 2. Lot Area No restriction
- 3. Lot Width No restriction
- 4. Front, Side, Yard and Rear Yard Setbacks 0 feet with recorded 5-ft maintenance easement for adjoining parcel, measured from the property line inward or minimum of 53-ft minimum to any property line, and; 15-ft to any property line adjacent to Vaughn Drive and 10-ft to any property line adjacent to any other street.
- 5. Height Restriction 35-ft, measured from <u>a level plane at</u> the average of the highest and lowest Flood Protection Grade (FPG) on the parcel.
- 4.6. There shall be no enclosed occupiable spaces below the highest FPG of the parcel. This restriction shall not apply to spaces intended primarily for parking, storage, housing a building's utility equipment, or maintenance if the space can be quickly cleared in the event of or protected from a flood. In the event of a conflict, the restrictions of the Floodplain Regulations shall supersede this clause.
- 7. Signage within the Historic district All signs within the Historical District require a Certificate of Appropriateness and must comply with the signage requirements of the City's Historic Ordinance 151.36.
- 8. All uses shall have a parking and occupancy contingency and evacuation plan for flood events approved by the Planning Staff prior to the start of construction.
- 1.9. No central trash collection points or dumpsters shall be placed within the required setback adjacent to another parcel.

B. Restrictions for Permitted Use

- 1. All permitted uses listed in Section 7.00 Official Schedule of District Regulations shall conform to the General Restrictions.
 - i. Signs intended to been seen outside of the lot line:
 - Shall not be obstructed in any way a driver's vision of the road or hinder his passage in any way. Further, no sign shall be placed so as to hinder or obstruct any pedestrian path. Preferably, the signs should be flush with the building façade.


- 2. Signs sShall meet the requirements of the Historic District and always be properly maintained.
- ii. Fences, Walls and Hedges:
 - 1. Notwithstanding other provisions of this ordinance, fences, walls and hedges may be permitted in a yard or along the edge of any yard, providing that driveway entrances are not shielded by fences, walls and hedges in such a way as to obstruct the view of a driver entering a public road from the driveway. All fences and walls must meet the requirements of the Historic District.
- iii.—Parking areas:- Notwithstanding Table 9-1 'Off Street Parking Requirements', residential uses shall include parking areas such that there is at least 1 space for each unit. No parking area may be located within the required setback adjacent to another parcel. All areas used for parking shall be located in the rear or side yard unless located in a parking structure that is integrated into the primary
- iv.iii. structure. All parking areas shall be screened from the view of the surrounding dwelling units.
- iv. iv. Lighting. Lighted areas shall be approved prior to development and shall be placed in such a way that they do not infringe upon the rights of adjacent property owners.
- 2. Dwelling Units (110)
 - i. Height Restriction Maximum 15-ft from the average of the highest and lowest Flood Protection Grade (FPG) on the parcel to the highest point of the structure.
- 3. Apartments and Condominiums (130)
 - i. Side and back yard setbacks shall be 10-ft on any side adjacent to a dwelling unit and shall be heavily landscaped to obscure the view from the adjacent parcel. No permanently affixed mechanical equipment, such as an HVAC condenser, shall be located within the required setback next to a dwelling unit.
- 4. Manufacturing Brewpub, Manufacturing Glass & Glassware, Manufacturing –
 Pottery & Related Products, Retail Hotels, Tourist Courts, Tourist Home, Residential
 Hotel, Motels & other Transient Housing, Retail Eating Places, Retail Drinking Places,
 Nursery, Primary & Secondary Education (220, 322, 325, 581, 582, 583, 681)
 - i. Side and back yard setbacks shall be 10-ft on any side adjacent to a dwelling unit and shall be heavily landscaped to obscure the view from the adjacent parcel. No permanently affixed mechanical equipment, such as an HVAC condenser, shall be located within the required setback next to a dwelling unit.
- 5. Parks, Playgrounds and Recreating Areas (711, 712, 719,721, 722, 723, 729, 742, 761, 762, 769, 790)
 - i. Side and back yard setbacks shall be 10-ft on any side adjacent to a dwelling unit and shall be heavily landscaped to obscure the view from the adjacent parcel.
- C. Restrictions for Conditional Uses
 - 1. All conditional uses permitted in the Official Schedule of Uses shall conform to the General Restrictions. In addition, the following restrictions, as appropriate, shall be observed.
 - i. Signs intended to been seen outside of the lot line:

- Shall not be obstructed in any way a driver's vision of the road or hinder his passage in any way. Further, no sign shall be placed so as to hinder or obstruct any pedestrian path. Preferably, the signs should be flush with the building façade.
- 2. Signs shall meet the requirements of the Historic District and always be properly maintained.
- ii. Fences, Walls and Hedges:
 - 1. Notwithstanding other provisions of this ordinance, fences, walls and hedges may be permitted in a yard or along the edge of any yard, providing that driveway entrances are not shielded by fences, walls and hedges in such a way as to obstruct the view of a driver entering a public road from the driveway. All fences and walls must meet the requirements of the Historic District.
- iii. Parking areas. All areas used for parking shall be located in the rear or side yard unless located in a parking structure that is integrated into the primary structure. All parking areas shall be screened from the view of the surrounding dwelling units. Notwithstanding Table 9-1 'Off Street Parking Requirements', residential uses shall include parking areas such that there is at least 1 space for each unit. No parking area may be located within the required setback adjacent to another parcel.
- <u>iv.</u> Lighting. Lighted areas shall be approved prior to development and shall be placed in such a way that they do not infringe upon the rights of adjacent property owners.
